Financial Conduct Authority Authorisation

On 1st December the first of the four regional 'Authorisation Windows' opened, and the other windows open on 1st January 2015, 1st February 2015 and 1st March 2015.

Whilst you may currently hold Interim Permission with the FCA to offer finance to your Patients, if you do not submit your application for Authorisation when invited to do so by the FCA, your Interim Permission will expire at the end of your Application Window. You will not be able to offer finance options to your Patients, and you will lose a valuable income stream.

Since 1st April, we have been in regular contact with the FCA, networking with their Staff and working extremely hard to understand their requirements so that we are in the best possible position to assist you with your application for Authorisation.
